Description

1. The Local Government Unit of General Tinio, Nueva Ecija, through the 20% DEVELOPMENT FUND for Year 2025 intends to apply the sum of Six Million Four Hundred Thousand Pesos (Php 6,400,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Concreting of Road Located at Purok Sagingan Barangay Nazareth, General Tinio, Nueva Ecija . Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Local Government Unit of General Tinio, Nueva Ecija now invites bids for the above Road Construction. Completion of the Works is required ninety (90) calendar days from the receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from Local Government Unit of General Tinio, Nueva Ecija and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
5. A complete set of Bidding Documents may be acquired by interested bidders on January 22, 2025 to February 11, 2025 from given address and website/s below and upon payment for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ten thousand pesos (Php10,000.00).

6. The Local Government Unit of General Tinio, Nueva Ecija will hold a Pre-Bid Conference on January 30, 2025 – 1:00 pm at 2nd Floor, Conference Room, Municipal Hall Building, LGU-Municipality of General Tinio, Nueva Ecija which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below on or before February 11, 2025 – 9:00 am. Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.

9. Bid opening shall be on February 11, 2025 – 1:00 pm at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Local Government Unit of General Tinio, Nueva Ecija reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
