Description

1) The Local Government Unit of General Tinio, Nueva Ecija, through the 20% Development fund Approved Budget for Year 2026 intends to apply the sum of Seven Million Five Hundred Thousand Pesos (Php 7,500,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Procurement of One (1) unit Self-Loading Truck. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2) The Local Government Unit of General Tinio, Nueva Ecija now invites bids for Procurement of One (1) unit 10wheeler Self-Loading Truck 5 tons boom and winch . Delivery of the Goods is required 30 calendar days from the date of NTP. Bidders should have completed, at least 2 years from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR of RA No. 12009.

i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4) Interested Bidders may obtain further information from Local Government Unit of General Tinio, Nueva Ecija and

inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.

5) A complete set of Bidding Documents may be acquired by interested Bidders on November 27, 2025 from the address given below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ten thousand pesos (Php 10,000.00)

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6) The Local Government Unit of General Tinio, Nueva Ecija will hold a Pre-Bid Conference on December 4, 2025 at 2nd Floor, Conference Room, Municipal Hall Building, LGU-Municipality of General Tinio, Nueva Ecija, which shall be open to prospective Bidders.

7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the office address indicated below on or before December 16, 2025 @ 9:00am. Late bids shall not be accepted.

8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.

9) Bid opening shall be on December 16, 2025 @ 10:00am at 2nd Floor, Conference Room, Municipal Hall Building, LGU-Municipality of General Tinio, Nueva Ecija. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.

10) The Local Government Unit of General Tinio, Nueva Ecija reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of R.A. No. 12009, without incurring any liability to the affected Bidder or Bidders.
